THIS AMENDMENT TO DECLARATION OF CONDOMINIUM ("Amendment") is made as of this /4th day of December, 2012, and is made by Beaucatcher House Condominium Association, Inc. ("Association"), pursuant to and under the North Carolina Condominium Act, Chapter 47C of the North Carolina General Statutes.

## WITNESSETH:

WHEREAS, Beaucatcher Condominium, LLC entered into and recorded a certain Declaration of Condominium for Beaucatcher House Condominium (the "Condominium"), on November 21, 2007, in Book 4491, at Page 859, Buncombe County Registry ("Declaration") which Declaration contained a set of Bylaws of the Beaucatcher House Condominium as an exhibit thereto (the "Bylaws"); and

WHEREAS, the Declarant Control Period as described in the Declaration has expired; and

WHEREAS, Article XI of the Bylaws of the Association as referenced above requires amendment in the same manner as the Declaration to which it is attached; and

WHEREAS, by a vote of over 67% of the Members of the Association, the Association membership has duly approved, at a special meeting on December 4, 2012 called for the purpose of amending the Bylaws, an amendment to the Bylaws in accordance with the terms below.

NOW THEREFORE, in consideration of the mutual obligations set forth herein, the parties hereto agree as follows:

- 1. Each and every term and provision of the Declaration, including each and every Exhibit thereto (including the Plans), is incorporated herein by reference, and is effective except as modified and amended by the terms and provisions of this Amendment.
- 2. The Bylaws of the Association (and therefore the Declaration by amendment of the Bylaws exhibit thereto) is amended as follows:

Section 3.5 of the Association Bylaws is amended to change the quorum requirement for Association membership meetings to 40% of the homeowners (members) present in person or by proxy.
